## Coronavirus restrictions in Pyhäjoki 3/1 - 15/1/2022

**On 29/12/2021, the Regional State Administration Agency has issued a decision under Sections 58 and 58 g of the Infectious Diseases Act for the region of Northern Ostrobothnia for the period of 01/01/2022 - 15/01/2022 ([see decision](#)).**

During its meeting on 3/1/2022, the Crisis Management Team of the Municipality of Pyhäjoki has decided on the restrictions to be introduced in Pyhäjoki on 03/01/2022 until 15/01/2022.

### **Coronavirus measures in the Municipality of Pyhäjoki 3/1 - 15/1/2022**

#### **Use of municipal premises**

- Library: subject to restricted use, 10 customers at once
- Gym: subject to restricted use, 5 customers at once

For the following establishments, access is closed pursuant to the order of the Regional State Administration Agency:

- School exercise facilities
- Sports Hall (Monitoimitalo)
- Monela

The establishments in question are however available for guided recreational activities for children born in 2005 and after and for the provision of legally mandated services.

#### **Extended remote work recommendation**

It is recommended that all employees work remotely as much as possible if it is possible in terms of work performance.

#### **Remote meeting practices**

It is recommended that the remote meeting practices are applied as comprehensively as possible, both at workplaces and at leisure time meetings.

#### **Mask recommendations**

The mask recommendations apply to over 12-year-olds.

Recommendation regardless of being vaccinated :

- in public indoor spaces and at public events
- in public transport and other public modes of transport, particularly during rush hours
- in schools, from grade 3 upwards and in upper secondary schools



- indoors at workplaces, if wearing a mask is possible.
- individuals travelling to provide a sample for a coronavirus test and before receiving the test results, if it is essential to travel outside the home.
- individuals arriving to Finland, when they are travelling from the point of entry into the country to the voluntary quarantine location, or if they have an essential reason to travel outside the home during the voluntary quarantine
- in indoor premises used for hobby and leisure activities, if several people are working or occupy the same premises
- social and healthcare workers when they are in close contact with patients or customers
- the recommendation also applies to patients, relatives, students and visitors.
- in the premises of private service providers (shops, banks, pharmacies, etc.)

#### **Public events and audience events**

The holding of indoor and outdoor public events and general meetings is prohibited in accordance with the Regional State Administration Agency's decision.

#### **Private events**

Private events are recommended to be organised in as small groups as possible.

#### **Risk groups**

- Visits to elderly and risk groups is recommended to be considered carefully. During any visitations, a mask and good hand hygiene is recommended.
- If any visit to individuals belong to elderly and risk groups, the "Visitations to long-term treatment and care operating units during the coronavirus epidemic" guidelines are observed (seekoronavirusaikana" -ohjeen mukaisesti ([kts. the Finnish Institute for Health and Welfare's guidelines](#)))

#### **Coronavirus vaccinations**

To achieve vaccine protection, those who are not fully vaccinated should seek to receive the recommended doses of COVID vaccine. ([see RAS' vaccines](#))

#### **Coronavirus test**

In case of respiratory symptoms, such as cough, throat ache, cold or breathing difficulties, please seek medical advice and be tested in accordance with the RAS guidelines. ([see RAS guidelines](#))

Home tests (antigen tests) are recommended as a good supplementary alongside coronavirus tests carried out by healthcare professionals. If a home test indicates a positive result, it must be confirmed with a coronavirus test completed by a healthcare professional. A negative home test shall not be release a person from official isolation or quarantine.
